INDIAN DEMOLITION ASSOCIATION (IDA)

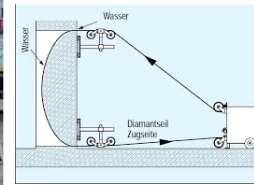

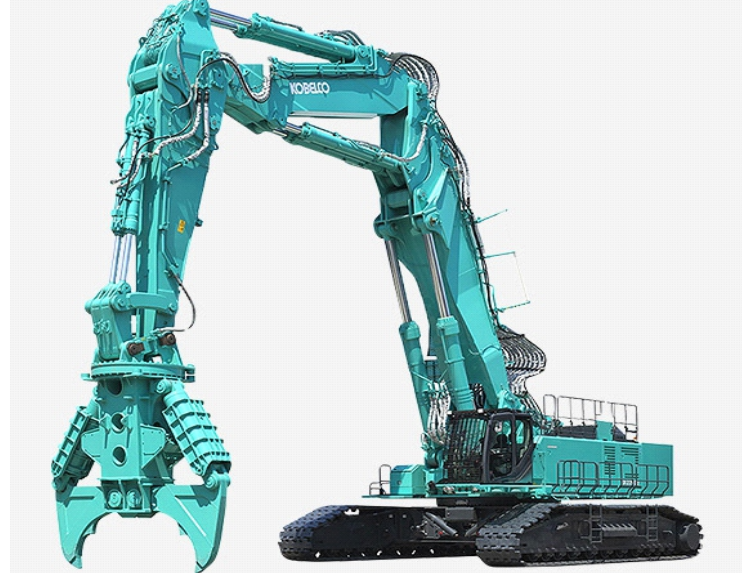

INDIAN ECONOMY



The Indian economy has rebounded strongly despite three significant COVID-19 waves, the US Treasury said in a report to the Congress in June this year. The Indian government continued to provide fiscal support to the economy against the backdrop of the pandemic in 2021. The authorities estimate that the overall fiscal deficit will reach 6.9 percent of GDP for the 2022 fiscal year, which is higher than deficits prior to the pandemic, it said.

According to the Treasury, the Reserve Bank of India kept its key policy rates unchanged at 4% since May 2020, but in January 2021 it began to gradually unwind the extraordinary liquidity measures designed to support growth during the early part of the corona virus pandemic.

The world is witnessing urbanisation at an unprecedented pace, which is expected to further accelerate, and India is anticipated to lead this growth. This rapid urbanisation coupled with a host of other factors such as favorable demographics, policy reforms undertaken and sound macro-economic fundamentals, have made India the fastest growing large economy in the world. The Indian real estate holds immense significance in the Indian economy with the sector being the third largest employer after agriculture and manufacturing.

INDIAN CONSTRUCTION INDUSTRY POST COVID FORECAST

According to an Economic Survey 2022 the construction sector is well on the path of growth trajectory and that the estimated growth would be 10.7% after a contraction during the first Covid-19 wave of 8.6% during the previous financial year.

“The 2022 Economic Survey infuses optimism for what lies ahead. The projection of 8-8.5% GDP growth for the fiscal 2022-23 will be led by supply-side reforms and easing of regulations. The survey also indicates that consumption is growing and inching closer to the pre-pandemic levels,” said Ramesh Nair, CEO, India and Managing Director, Market Development, Asia, Colliers.

Here are a few facts on the state of the Construction Industry as it stands today.

- As per Investing, the Indian construction industry will reach \$1.4 Trillion by 2025.
- Cities Driving Growth – Urban population contributes 75% of GDP (63% present), and 68 cities will have more than 1 million, up from 42 today.
- The construction industry market in India works across 250 sub-sectors with linkages across sectors.



INDIAN RECYCLING INDUSTRY

C&D Waste Recycling Policy of GOI

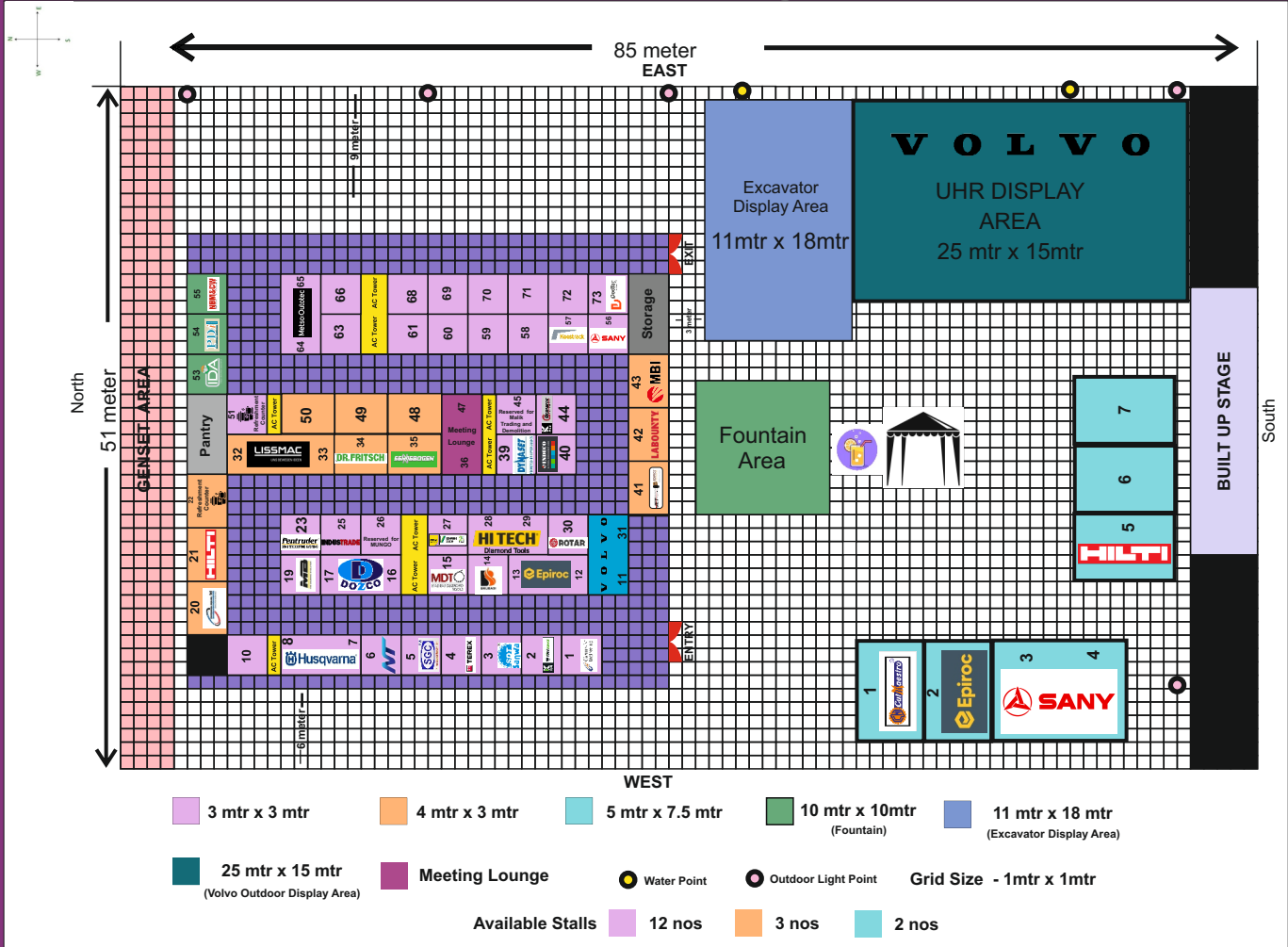
Government of India released the C&D Waste Management Rules 2016 which mandated every State government to implement it. The Rules simply stipulates that every city in India with over 1 Million population should ensure the C&D waste generated will be recycled. The Rules give clear guidelines as how to implement the policy. This opens up immense opportunities for foreign manufacturers to share their experiences in their own countries and educate Indian stake holders and contractors. Bureau of Indian Standards(BIS) have, on their part modified the Codes of practice to allow Recycled Aggregates in concrete construction. Nowadays, all owners are looking at Recycling as an option, both for compliance as well as from sustainability point of view.

Vehicle Scrapage Policy of GOI

Government of India introduced the Vehicle Scrapage Policy in 2021. The Vehicle Scrapage Policy 2021, focuses on phasing out old and unfit vehicles. It aims to de-register private cars over 20 years old and commercial vehicles over 15 years old. This policy mandates scrapping of all old and polluting vehicles from indian roads. GOI also announced incentives for new vehicle buyers, especially for EVs. This gives enormous opportunities for entrepreneurs and original vehicle manufacturers (OEM) to set up scrap processing plants across India. Few of the large vehicle manufacturers have already set up pilot plants. The demand for such plants will grow rapidly and this will be new opportunity in India.
